# **IMPACT OF COVID-19**

#### Comments

The current Covid-19 outbreak has led to multiple travel, movement and congregation restrictions in many countries, predominantly impacting the tourism, transport and logistics industry but also a variety of other businesses that rely on the physical presence of their workforce and/or customers. This is expected to have an adverse effect on these companies' bottom line and their ability to duly meet their financial and trade obligations in the future.

Set to last until April 7, but officials could extend or shorten that time.

## **Description:**

Gov. Gavin Newsom issued an order mandating that individuals must stay home, except for activity "needed to maintain continuity of operation of the federal critical infrastructure sectors, critical government services, schools, childcare, and construction." Essential services will remain open, such as grocery stores and pharmacies. Newsom signed in executive order March 30 ordering a 90-day extension for small businesses for tax returns and tax payments. The order also extends the statute of limitations to file tax refund by 60 days. Nonessential medical care and elective procedures must be rescheduled. With some exceptions, people are not allowed to visit family members in hospitals or nursing homes.
